Career Conversion Programme (CCP) - WSG Salary Support Rate#

- For Singapore citizens and PRs < 40 years old: Up to 70% of monthly salary (capped at \$4,000 per month)
- For Singapore citizens and PRs ≥ 40 years old: Up to 90% of monthly salary (capped at \$6,000 per month)
