All applicants are required to pay a non-refundable application fee of S\$87.20 upon course registration.

Funding Support:

SkillsFuture Baseline Funding: Up to 70% of course fees (Applicable to Singapore Citizens, Singapore Permanent Residents, and Long-Term Visit Pass Plus (LTVP+) holders aged 21 years and above).

SkillsFuture Mid-Career Enhanced Subsidy (MCES): Up to 90% of course fees (Applicable to Singapore Citizens aged 40 years and above).

SkillsFuture Career Transition Programme (SCTP) – Additional Funding Support (AFS)

Applicable to Singapore Citizens only, under the following categories:

- Long-term unemployed individuals (unemployed for six months or more)
- Individuals requiring financial assistance – recipients of ComCare Short-to-Medium Term Assistance (SMTA) or Workfare Income Supplement (WIS)
- Persons with Disabilities

Note: All AFS applicants are required to submit valid supporting documents to be considered for AFS funding. Eligibility is subject to SkillsFuture Singapore (SSG)'s assessment and approval.

SkillsFuture Credit & PSEA Usage:

Course fees may be further offset using:

- SkillsFuture Credit (opening and top-up) – for Singapore Citizens aged 25 and above
- SkillsFuture Credit (Mid-Career) Top-Up S\$4,000 – for Singapore Citizens aged 40 and above
- Post-Secondary Education Account (PSEA) – for Singapore Citizens aged 21 to 31
