Funding Support:

SkillsFuture Baseline Funding: Up to 70% of course fees (Applicable to Singapore Citizens, Singapore Permanent Residents, and Long-Term Visit Pass Plus (LTVP+) holders).

SkillsFuture Mid-Career Enhanced Subsidy (MCES): Up to 90% of course fees (Applicable to Singapore Citizens aged 40 years and above).

Enhanced Training Support for SMEs (ETSS): SMEs can receive SkillsFuture funding, of up to 90% of the course fees when they sponsor their employees to attend SWDA-supported courses.
